**Some things to note:** Individual membership dues are \$90 per year. Dues for a full year are payable when you are voted in as a member. In addition to your first year's dues, you will pay a one-time \$10 fee for an access key card. This card becomes your permanent membership card and remains activated in the locks as long as your dues are paid.

All membership applicants and those applying for reinstatement are required to complete the Outdoor Range Safety Orientation prior to gaining membership. A separate Indoor Range Qualification is required to use the indoor range after you become a member. There is no additional fee for this.

**In consideration of review by Lincoln County Rifle Club (LCRC) of this application and of membership if approved, I hereby certify and agree as follows:**

- I am a citizen of the United States, 18 years of age or older.
- I am not legally prohibited from possessing a firearm under any law, including but not limited to prohibition due to conviction of a felony or crime of domestic violence, or is subject to a court order for harassment, stalking or threatening of a type that prohibits possession of a firearm.
- I will immediately notify LCRC of any subsequent incident that prohibits me from possessing a firearm, which will subject my application or membership to immediate review and appropriate action. Notification shall be made to the LCRC president, vice-president, treasurer or secretary.
- I agree to abide by the rules and bylaws of LCRC as they may be amended from time to time, will fulfill the obligations of good sportsmanship and citizenship, and I have not participated, nor will I participate, in any activity that advocates violence within the United States.
- I understand that shooting is inherently risky if firearms are not handled properly and assume any risk of bodily injury, death, or property damage arising out of or related to any activity conducted on or near the property of LCRC, whether or not caused by negligence or otherwise of LCRC, its officers, directors, and agents (together herein "releasees").
- I understand that LCRC reserves the right to decline any application.

I hereby release, waive and discharge releasees from, and covenant not to sue releasees for, any and all loss or damage and any claim or demands therefrom on account of injury to my person or property arising from my participation in activities at LCRC. I further hereby indemnify and hold harmless releasees for any claims of damage or injury, including for releasees' reasonable attorney fees and costs, arising from my said participation and actions at Club property, and/or breach of any of the above certifications.
